REMARKS:

When I arrived at the premises, I walked to the back where the animals are housed and found the kennel attendant nebulizing a French bulldog in the isolation area. I asked him why he was being nebulized and he told me that he was told the dog was sick. I inquired about the whereabouts of the medical record from the veterinarian and found none. When the manager arrived, he was unaware that the dog was being nebulized and didn't know if the dog had been to the vet or not since there were no records indicating such event. I also inquired as to why he was nebulizing the dog at the store since the veterinary plan states that all sick dogs immediately go to the veterinarian and he did not know. The kennel attendant cleaned the isolation area of the debris and placed both French Bulldogs in the area.
