A puppy returned to the store on 7/7/12 due to health concerns was not examined by a veterinarian until 7/11/12. Section 401.5(d) of Article 26-A requires a pet dealer to provide proper veterinary care without undue delay when an animal is returned.

The store provided health care to a purchaser's puppy from 7/1/12 until 7/3/12. A pet dealer cannot administer veterinary care to an animal that is not owned by them. Section 6701 of Article 135 of NY State Education Law defines the practice of veterinary medicine as "diagnosing, treating, operating, or prescribing for any animal disease, physical condition", etc. Only a person licensed or exempt under Article 135 shall practice veterinary medicine. A pet dealer is not exempt under the law.
