**Pet Dealer requests to opt out of program. There are 11 dogs currently residing at the Indiana Ave. address. There are 7 intact females, 2 spayed females, 1 castrated male and 1 intact male.**

**Two dogs (Dijoe - neutered male and China - intact female) are currently being advertised on Craig's List under Glens Falls as "Pet Dealer going out of business".**

**In order for Ms. Storm to opt out of the Pet Dealer Licensing Program I reviewed the Pet Dealer requirements. Advised Pet Dealer Storm and Mr. Eddy that any dogs or cats imported from outside sources must not exceed more than 9 animals/per year and animals that are born and raised on the premises must not exceed 24 animals/ year. If animals are imported and raised on the premises the number must not exceed 9 in a calendar year.**
