



International Pet Bird Travel: Bringing Pet Birds Back to the U.S.



Avoid Problems with Your Return; Know the U.S. Re-Entry Import Pet Bird Requirements

To prevent the spread of avian diseases, birds coming into the United States (U.S.) are subject to quarantine. Pet birds meeting certain criteria may undergo this quarantine at home. First, your birds must be of U.S. origin, meaning born or purchased in the U.S. Second, if your bird weighs more than 100 grams, its identification (microchip, leg band or tattoo) must be documented on the U.S. Origin Health Certificate. Third, your

bird may not have traveled to a country affected by an avian foreign animal disease (i.e., Highly Pathogenic Avian Influenza or Exotic Newcastle Disease). Finally, your pet bird must meet all other import requirements outlined in this document.

Plan ahead and follow these steps to bring your pet bird back to the U.S. from a foreign country other than Canada or Mexico.

Step 1. Locating a copy of your pet bird's U.S. Origin Health Certificate and CITES document

Before you can return to the U.S. with your pet bird, you must have in your possession a photocopy of your bird's U.S. Origin Health Certificate, which would have been issued PRIOR to departure from the U.S. and included information about your bird's identification, and/or a U.S. Fish & Wildlife Services' Convention on International Trade in Endangered Species of Wild Fauna and Flora (CITES) document (if applicable).

Step 2. Requesting an Import Permit for your pet bird

Prior to bringing your pet bird back to the U.S., you must contact the U.S. Department of Agriculture (USDA), Animal and Plant Health Inspection Service (APHIS)'s Veterinary Services (VS) to request an Import Permit. At this site you will find step-by-step instructions on the import application and fees and payment options for processing the application. The minimum estimated fees for pet bird importation are \$650. You can expect to receive your permit approximately 7-10 business days after submitting your application.

Step 3. Acquiring a veterinary health certificate

Within 30 days before returning to the U.S. with your pet bird, you need to request a health certificate from the country you are leaving.

It must be stamped by an official veterinarian of that country.



Step 4. Contacting the VS Port Veterinarian prior to U.S. arrival

Before you begin your trip back to the U.S., be sure to contact the VS Port Veterinarian to confirm your arrival date and time. Contact information for this office is located on your USDA Import Permit. If you anticipate arriving outside normal business hours, you may incur additional fees. If your bird is microchipped with non-ISO compliant chip, you must provide your own handheld reader.

Step 5. Meeting with the VS Port Veterinarian on arrival at the port of entry

When you arrive in the U.S. with your pet bird at the port of entry, you must have these documents with you:

1. U.S. Origin Health Certificate (see step 1)
2. CITES document (if needed)
3. USDA Import Permit (see step 2)
4. Current veterinary health certificate (see step 3)

A VS Port Veterinarian must examine and test all pet birds returning to the U.S. for avian influenza and exotic Newcastle disease. USDA testing fees apply.

Step 6. Quarantining your pet bird at home for 30 days

After your pet bird is examined by the VS Port Veterinarian and its identification verified, it can go home with you. However, it must be separated and apart from all other birds and poultry for a minimum of 30 days, as part of quarantine requirements. A VS veterinarian will test your bird again approximately 14 days after arrival in the United States.

Step 7. Receiving your written notification of release from quarantine

After 30 days of quarantine and assuming all test results are negative, you will receive written notification from VS releasing your pet bird from home quarantine. After that notification, your bird can move freely anywhere in the United States.
